**PHARMACY TECHNICIAN  
Training Program**

**Tuition: \$1399; Course Hours: 50+40 hour optional externship**

Mississippi College and Condensed Curriculum International are pleased to offer this comprehensive course to prepare students to take the Pharmacy Technician Certification Board’s PTCB exam. Technicians work under the supervision of a registered pharmacist in hospitals, home infusion pharmacies, community pharmacies, and other health care settings. Course content includes: pharmacy medical terminology, the history of pharmacy, the pharmacy practice in multiple environments, pharmacy calculations and measurements, reading and interpreting prescriptions and defining drugs by generic and brand names. Through classroom lectures and hands-on labs, students will review dosage calculations, drug classifications, the “top 200 drugs”, I.V. flow rates, sterile compounding, dose conversions, aseptic technique, the handling of sterile products, total parenteral nutrition (TPN), dispensing of prescriptions, inventory control and billing and reimbursement.

**Educational Requirements:** High School Diploma or GED required to sit for the PTCB and PTAC exams.

**Clinical Externship:** As part of this Pharmacy Technician program, you will be eligible to participate in an 80 hour clinical externship.
